Step 1: Select Your Country

Choose the country, region or U.S. state you're interested in owning.

Step 2: Qualification Requirements

Before you can buy, you must confirm understanding of these rules →

Qualification Requirements:

*01

Only **NEW IMPT** tokens purchased from a decentralized exchange (DEX) qualify.

*02

You must stake those tokens directly on the **DEX platform** — simply holding in your wallet is NOT enough.

*03

You'll earn **8% APY**, **50% of IMPT's margin** from your country, and lifetime revenue from all users who register in your country—even if they travel and shop globally!

*04

Step 3: Verification

After you purchase and stake your tokens, IMPT will manually verify you've used newly bought tokens and are staking them correctly.

Step 4: Revenue Begins!

Once ownership is confirmed, you start earning:

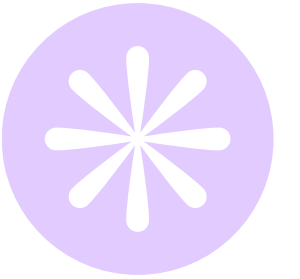

- *Ownership is **fully transferable** (can be sold or transferred as a digital asset).*

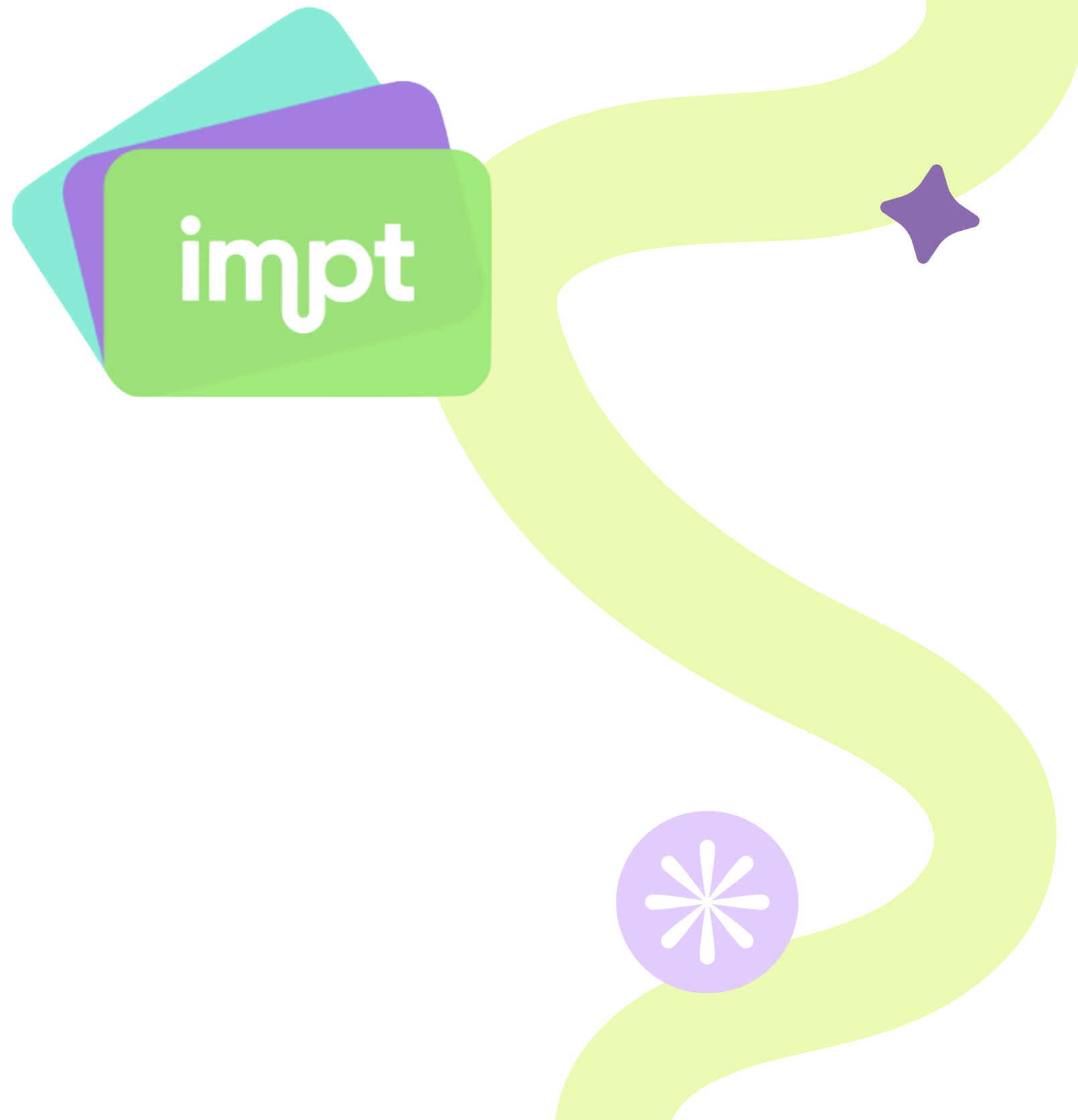
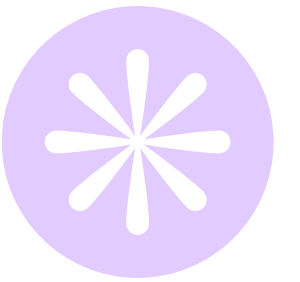

Why the IMPT platform?

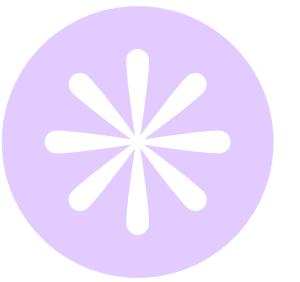

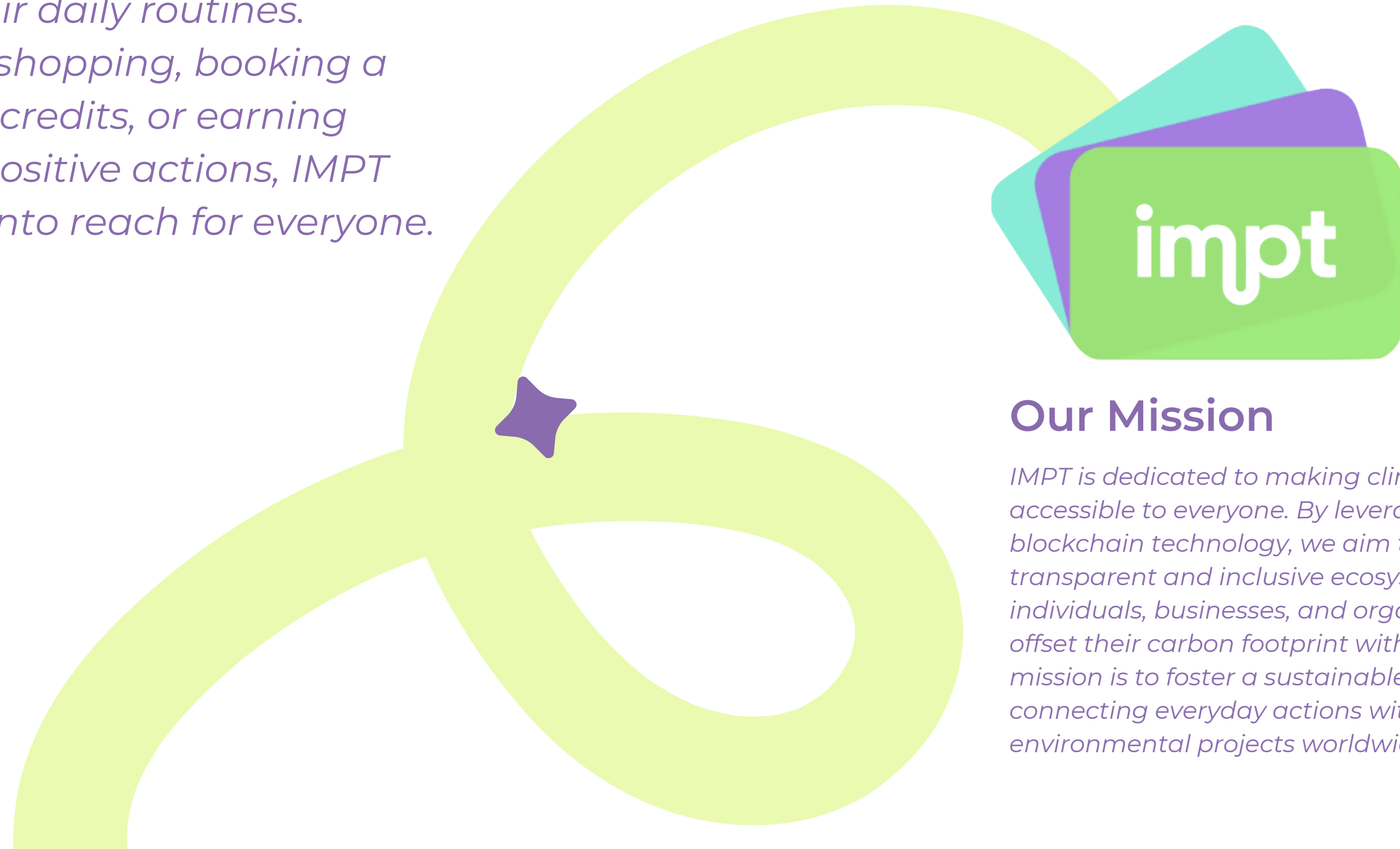
